

ICO TERMS AND CONDITIONS

AFTR PTY LTD (TRADING AS CHOZUN LABS) referred to as “chozun”

This page informs you of the Terms and Conditions governing use of the information and functionality offered at ico.chozun.com & ico.chozun.com (“Website”). By using the Website, you agree to be bound by these Terms and Conditions.

1. The Website does not constitute a prospectus of any sort, is not a solicitation for investment and does not pertain in any way to an offering of securities in any jurisdiction.
2. By transferring ETH, BTC, or any other cryptographic tokens (“Cryptocurrency”) to obtain CZN tokens (“CZN” or “CZN tokens”) and/or receiving CZN, no form of partnership, joint venture or any similar relationship is created between the user and the creators of CZN and/or any other individuals involved with the Website or CZN.
3. By transferring Cryptocurrency to obtain CZN tokens and/or receiving CZN, the user confirms that the user is neither a United States citizen or People’s Republic of China. If you proceed with the purchase of CZN as a citizen of either of these countries, you do so at your own risk.
4. By transferring Cryptocurrency to obtain CZN tokens and/or receiving CZN, the user expressly represents and warrants that:
 - a. The user understands the functionality, usage, storage, transmission mechanisms and intricacies associated with cryptographic tokens and blockchain-based software systems;
 - b. The user has carefully reviewed the code of the smart contract located on the Ethereum blockchain at the addresses set forth on the Website and fully understands and accepts the functions implemented therein;
 - c. The user is legally permitted to transfer Cryptocurrency to obtain CZN tokens, and is legally permitted to obtain CZN in the user’s jurisdiction;
 - d. The user is legally permitted to interact with the CZN tokens smart contract;
 - e. The user is of a sufficient age to legally obtain CZN tokens;
 - f. The user will take sole responsibility for any restrictions and risks associated with obtaining CZN tokens by the smart contract system;
 - g. The user is not submitting Cryptocurrency to obtain CZN for the purpose of speculative investment;
 - h. The user is not obtaining or using CZN for any illegal purposes;
 - i. The user waives the right to participate in any lawsuit or legal action against any entity or individual involved with the Website or with the creation or distribution of CZN tokens;
 - j. The user understands that submitting Cryptocurrency to obtain CZN does not involve the purchase of shares or any equivalent in any existing or future public or private company, corporation or other entity in any jurisdiction;
 - k. The user understands and expressly accepts that there is no warranty whatsoever on CZN, expressed or implied, to the extent permitted by law, and that the smart contract system is used and CZN are obtained at the sole risk of the user on an “as is” basis and without, to the extent permitted

by law, any warranties of any kind, including, but not limited to, warranties of title or implied warranties, merchantability or fitness for a particular purpose;

l. The user understands that the user has no right against any party to request any refund of the Cryptocurrency submitted to obtain CZN tokens under any circumstance;

m. The user understands that the user bears the sole responsibility to determine if the transfer of the Cryptocurrency to obtain CZN tokens, the obtaining, ownership, or use of CZN, and/or any other action or transaction related to CZN may have tax implications for the user;

n. By obtaining, owning or using CZN, and to the extent permitted by law, the user agrees not to hold any party liable for any tax liability associated with or arising from obtaining, owning or using CZN or any other action or transaction related to the Website.

The user acknowledges and agrees that, to the fullest extent permitted by any applicable law, the user will not hold any developers, contractors or creators of CZN tokens and/or the Website liable for any and all damages or injury whatsoever caused by or related to the use of, or the inability to use, CZN tokens or the Website under any cause or action whatsoever of any kind in any jurisdiction, including, without limitation, actions for breach of warranty, breach of contract or tort (including negligence) and that developers, contractors or creators of the Website and/or CZN tokens shall not be liable for any indirect, incidental, special, exemplary or consequential damages, including for loss of profits, goodwill or data, in any way whatsoever arising out of the use of, or the inability to use the Website and/or CZN tokens.

The user agrees that if any portion of these Terms and Conditions is found illegal or unenforceable, in whole or in part, such provision shall, as to such jurisdiction, be ineffective solely to the extent of such determination of invalidity or unenforceability without affecting the validity or enforceability thereof in any other manner or jurisdiction and without affecting the remaining provisions of the Terms and Conditions, which shall continue to be in full force and effect.

These Terms and Conditions are effective as of 1 November 2017 and will remain in effect, except with respect to any changes in their provisions in the future, which will be in effect immediately after being posted on this page. The Terms and Conditions can be updated or changed at any time and you should check these Terms and Conditions periodically. Your continued use of the Website and/or CZN tokens after any modifications to the Terms and Conditions are posted on this page will constitute your acknowledgment of the modifications and your consent to abide and be bound by the modified Terms and Conditions.
